# WHY WE UPDATE THE TOKENOMICS?

Key reasons for the update:

- Market adaptation (2025): align with current Layer-1 standards and investor expectations.
- Accessibility: lower nominal price (\$0.025) enables broader participation and global reach.
- Sustainability: dynamic halving (2y→5y) ensures smoother, long-term inflation control.
- Trust & transparency: multi-signature wallets, time-locked smart contracts, and public wallet registry.
- Adoption readiness: optimized model supports institutional partners and mass adoption.

In short: this evolution makes Savitri more stable, inclusive, and ready for the next phase of growth – without changing its vision or reducing any holder's value.

# HOW \$SAVI IS USED

## \$SAVI COIN UTILITY – POWERING THE SAVITRI ECOSYSTEM

**Transaction Fees** : Fixed ultra-low fee (\$0.0035 per tx) for all on-chain operations.

**Staking Rewards**: Lock \$SAVI to secure the network and earn rewards (8% → 5% → 3%).

**AI Services** : Pay per query (e.g., 0.1 \$SAVI per AI request) for decentralized AI computing.

**IoT Data Integration** : Devices pay micro-fees in \$SAVI (e.g., 0.01 \$SAVI per data packet) for trusted data streams.

**Validator Incentives** : Validators earn \$SAVI for maintaining consensus and processing transactions.

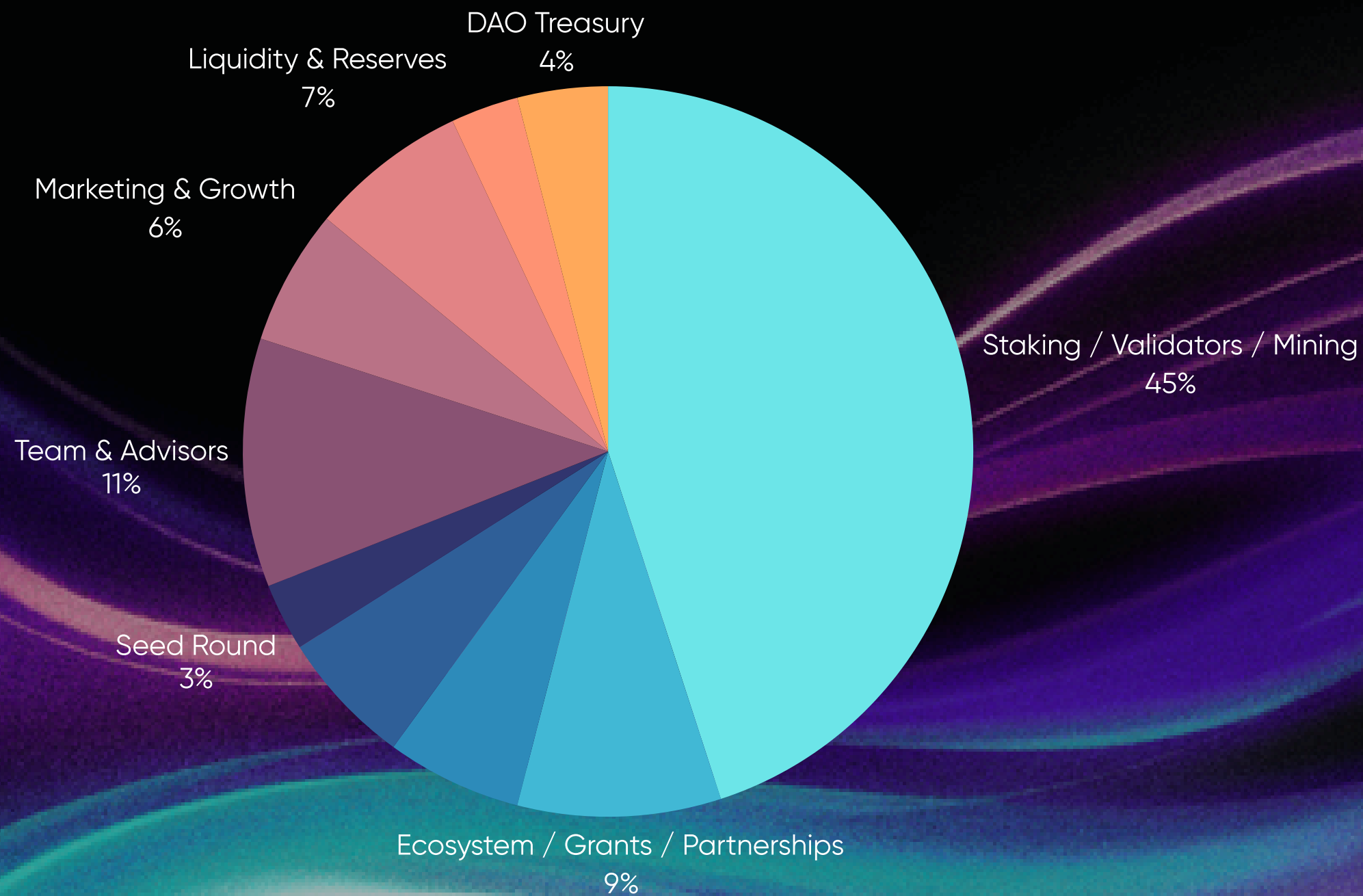
**Marketplace Payments** : \$SAVI used for decentralized apps, SaaS subscriptions, and ecosystem services.

**Deflationary Mechanism** : from 0.1% to 1% burn on each transaction, increasing scarcity and value over time.

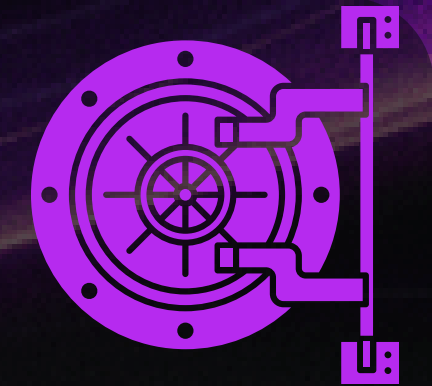

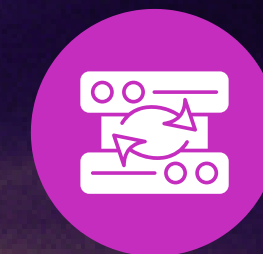
